

On April 4th 2019 RSA reminded customers about the upcoming **End of Primary Support date** for RSA NetWitness Platform version 10.6. Customers who are still running v10.6.x or lower will need to upgrade to version 11 by **October 2019** to remain on a supported version of the platform. We encourage all customers to begin planning their upgrade right away to ensure a smooth transition while upgrading. ~400 customers have already upgraded to v11.x. Many of these customers upgraded on their own, but if assistance is requested we have services teams from support and professional services who are ready to help.
