## Introduction to Prisma Access

---

Prisma Access helps you deliver consistent security to your remote networks and mobile users. All your users—at headquarters, office branches, and on the road—connect to Prisma Access to safely use the internet and cloud and data center applications. You get protection at scale with global coverage, so you don't have to worry about things like sizing and deploying firewalls at your branches, or building out and managing appliances in collocation facilities.

With Prisma Access, Palo Alto Networks deploys and manages the security infrastructure globally to secure your remote networks and mobile users. Prisma Access logs directly to Cortex Data Lake. All Prisma Access logs are stored in the Cortex Data Lake, providing centralized analysis, reporting, and forensics across all users, applications, and locations.

Palo Alto Networks Cortex Data Lake provides cloud-based, centralized log storage and aggregation for your on-premise, virtual (private cloud and public cloud) firewalls and for Prisma Access.

Cortex Data Lake is secure, resilient, and fault-tolerant, and it ensures your logging data is up-to-date and available when you need it.

To meet your long-term storage, reporting and monitoring, or legal and compliance needs, you can configure Cortex Data Lake to forward all logs or a subset of logs to our Netwitness syslog receiver.

### Supported Log Types

We support the collection of various log types from the Cortex Datalake, such as Traffic, Authentication, System, Config, GlobalProtect, HIP Match, File, etc.

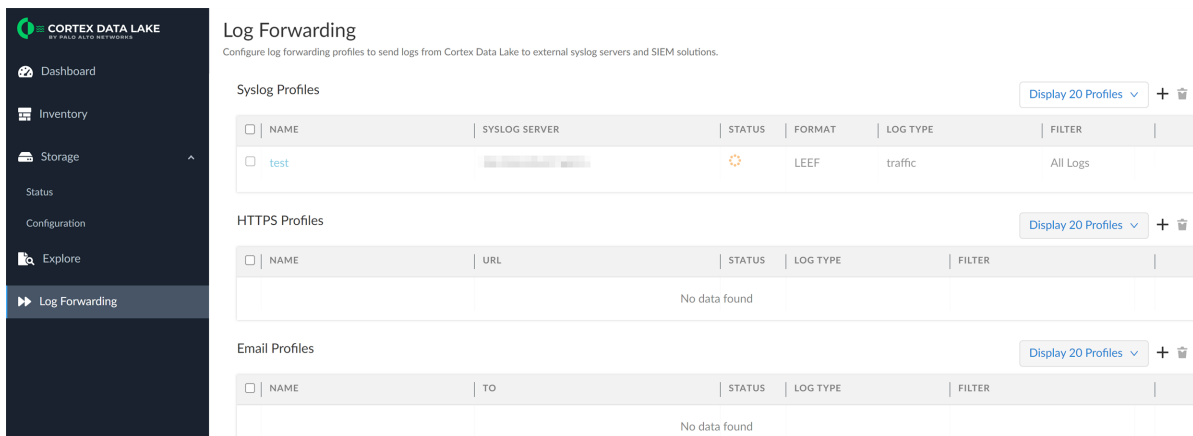
# Forward Logs from Cortex Data Lake to a Syslog Server

Configure the Cortex Data Lake to forward logs to syslog receiver at Newtitness, see [Forward Logs from Cortex Data Lake to a Syslog Server](#).

**Note:** For any inquiries regarding the configuration process on Cortex Data Lake, please contact Palo Alto Networks support.

During the configuration of your Cortex Data Lake instance, it is essential to ensure that below parameter details are entered accurately.

- Syslog Server - Enter the IP address or hostname of the NetWitness Log Decoder or Remote Log Collector.
- Log Format - LEEF (Tab delimiter).



# Configure Syslog Event Sources on the NetWitness Platform

This section provides instructions for configuring the Palo Alto Prisma Access with NetWitness Log Collector. It is assumed that the reader has both working knowledge of all products involved, and the ability to perform the tasks outlined in this section. Administrators should have access to the product documentation for all products to install the required components.



Perform the below steps on the NetWitness Platform to configure Syslog Event Source:

## Enable the Required Parser

If you do not see your parser in the list while performing this procedure, you need to download it in NetWitness Platform Live.

**To enable the required parser:**

1. In the **NetWitness** Platform menu, select  (Admin) > **Services**.
2. In the **Services** grid, select a Log Decoder, and from the **Actions** () menu, choose **View > Config**.
3. In the **Service Parsers Configuration** panel, search for your event source, **paloaltonetworks** and ensure that the **Config Value** field for your event source is selected.



The new device is listed under the Log Decoder(s) General Tab within the **Service Parsers Configuration**.

**Note:** The required parser is *paloaltonetworks*.



## Configure NetWitness Platform for Syslog Collection

**Note:** You only need to configure Syslog collection the first time that you set up an event source that uses Syslog to send its output to NetWitness. You only need to configure either the Log Decoder or the Remote Log Collector for Syslog, not both.



**To configure Log Decoder for Syslog Collection**

1. In the NetWitness Platform menu, select  (Admin) > **Services**.
2. In the **Services** grid, choose a Log Decoder and from the **Actions** () menu, choose **View > System**.

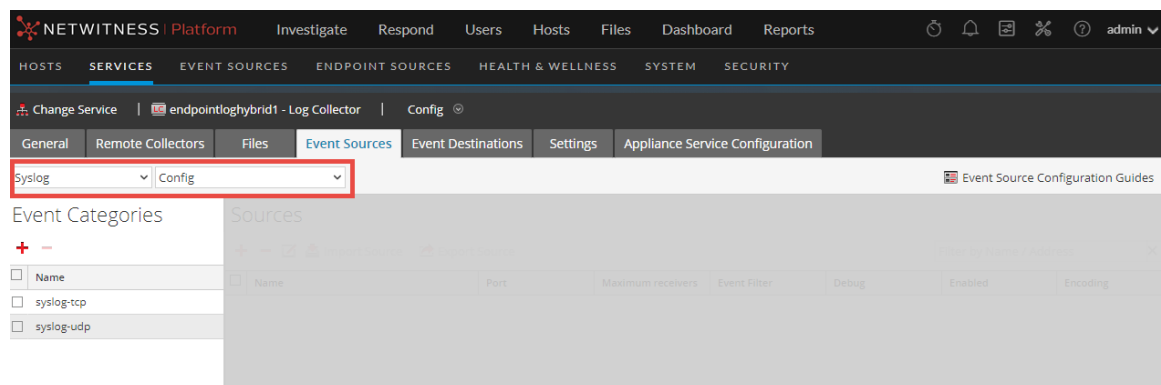
3. Depending on the icon you see, do one of the following:

- If you see  **Start Capture**, click the icon to start capturing Syslog.
- If you see  **Stop Capture**, you do not need to do anything; this Log Decoder is already capturing Syslog.

### To configure Remote Log Collector for Syslog Collection

1. In the NetWitness Platform menu, go to  (Admin) > **Services**.
2. In the **Services** grid, select a Remote Log Collector and from the **Actions** () menu, choose **View > Config > Event Sources**.
3. Select **Syslog / Config** from the drop-down menu.

The **Event Categories** panel displays the Syslog event sources that are configured, if any.



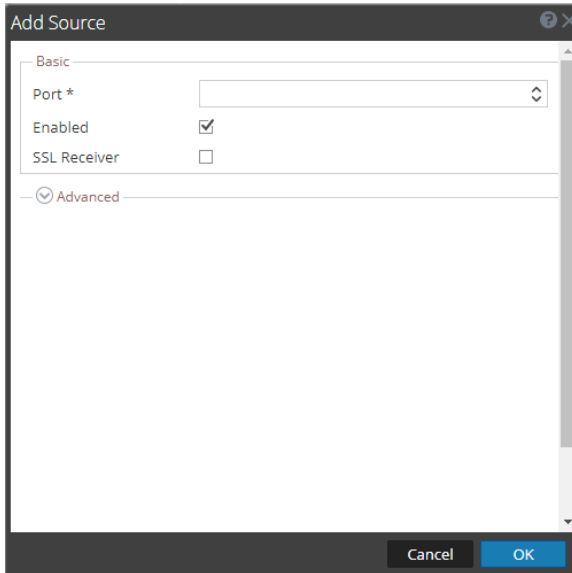
4. In the **Event Categories** panel toolbar, click **+**.

The **Available Event Source Types** dialog will appear.

5. Choose either **syslog-tcp** or **syslog-udp**. You can set up either or both, depending on the needs of your organization.



6. Choose the **New Type** in the **Event Categories** panel and click **+** in the **Sources** panel toolbar.  
The **Add Source** dialog will appear.



7. Enter **514** for the port and choose **Enabled**. Optionally, configure any of the Advanced parameters as necessary.

Click **OK** to accept your changes and close the dialog box.

After you configure one or both syslog types, the Log Decoder or Remote Log Collector collects those types of messages from all available event sources. You can continue to add Syslog event sources to your system without a need to do any further configuration in NetWitness Platform.
